- The Bid should be accompanied by Earnest Money Deposit of Rs. 10,000/- by way of Demand Draft Only in favour of" The Oriental Insurance Company Limited " , in the absence of which the bids will be treated as rejected. Bids/ Offers accompanied by payment of Earnest Money Deposit through cheque will also be treated as rejected.
- It is informed to all the Bidders that in addition to payment of Bid Price they have to pay 18 % GST on the Net Amount ( ie. Bid / Sale Price minus WDV of Car ) as per GST rules applicable on sale of second hand cars.
