The obligations of the Guarantor shall not be affected by any variations in the terms and conditions of the Agreement or other documents or by the extension of time for performance granted to the Agency or postponement/non exercise/ delayed exercise of any of its rights by The OICL or any indulgence shown by The OICL to the TPA and the Guarantor shall not be relieved from its obligations under this Guarantee on account of any such variation, extension, postponement, non-exercise, delayed exercise of any of its rights by The OICL or any indulgence shown by The OICL, provided nothing contained herein shall enlarge the Guarantor's obligation hereunder.
