### **General Instructions**

This invitation to Tender is for: -

- 1. Supply of SMF (VRLA) Batteries of <u>Amaron Quanta / Exide / Panasonic make</u> batteries for UPS to any of the offices of <u>The Oriental Insurance Company Limited's Regional office Jaipur</u>, at locations specified in Annexure A. The type of batteries required are: Standard Maintenance Free.
- Tenderers are advised to study the Tender Document carefully. Submission of Tender shall be deemed to have been done after careful study and examination of the Tender Document with full understanding of its implications.

#### 3. Schedule for Invitation to Tender:

### 1) <u>Performance Security</u>

The price can be revised after completion of each year from date of awarding the contract, based on satisfactory services, mutual consent and revision in market prices of brands as mentioned in the contract and can be extended further upto 2 iterations.
